

The liner project proposal land in question had been allotted to IDCO, Bhubaneswar for the purpose of construction of Approach Road to Gothapatana Industrial Estate.

The project area is situated outside the Eco- Sensitive Zone of Chandaka – Dampara Wildlife Sanctuary.

The Trees enumerated in the project area will be removed and the User Agency will provide a green belt plantation along both sides of the road.
