Name of the Project:-Laying Shifting of New 11KV line from Dungdoroo to Sewarbhati in Marwah Forest Division.

SITE INSPECTION REPORT

1. A proposal of Electric Division Kishtwar JPDCL is recommended by DFO Marwah in Parivesh Portal for diversion of Forest land under Forest conservation Act 1980 for non forestry purpose. The project envisaged diversion of 2.982 hac of forest land at Marwah Forest Division in District Kishtwar in favour of Electric Division Kishtwar JPDCL for Laying Shifting of New 11KV line from Dungdoroo to Sewarbhati in the UT of J&K in Marwah Forest Division. The site inspection of the spot involved in the proposal has been done by the Divisional Forest Officer Marwah on 07-04-2022.
2. No protected / heritage site /defence establishment etc is located in the area.
3. No Rare/endangered/unique species of flora and fauna found in the area.
4. No violation of the Act has been carried out by the user agency as the work for this proposal is yet to be started which shall be allowed only after clearance of the proposal by competent authority.
5. Whether site, where the forest land involved is located has been inspected by concerned Conservator of Forests (No).
6. Whether the concerned Conservator of Forests agree with the information given in Part-B and the recommendations of Divisional Forest Officer (Yes).

SPECIFIC RECOMMENDATION:-

The proposal may be accepted as per guideline of Govt. of India as the Forest land proposal for diversion of 2.982 hac of Forest land is essentially required for Laying Shifting of New 11KV line from Dungdoroo to Sewarbhati by Electric Division Kishtwar JPDCL in the UT of J&K of Marwah Forest Division. The 11KV line to be shifted feeds electricity to whole Tehsil of Dacchan. It has come under the Pakal Dul Hydroelectric Project and there is no route available other than the proposed one. Due to this reason the laying/shifting of new 11KV from Dungdoroo to Sewarbhati needs to be shifted. Submitted by Divisional Forest Officer Marwah is recommended to be accepted.
