SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF (For the forest land to be diverted under FCA)

A proposal has been received by this office from **NHAI Gorakhpur** for Development of 4/6 Lane North-East side Gorakhpur bypass starting from NH-29E (chainage 83+308) and end at NH-28 (chainage 285+100) under NHDP Phase- VII in District- Gorakhpur (Uttar Pradesh) under (Forest Conservation Act, 1980) for Diversion of 4.495 ha. forest Land In Bangai Reserved Forest and 0.451 ha. Protected Forest land along NH-28 (Gorakhpur to Kushinagar Road) and Gorakhpur- Pipraich Railway line with total area of 4.946 ha. Reserved /Protected forest land and 1390 tree cutting is involved for Non Forestry Purpose for Construction of bypass in Gorakhpur.

The site inspection of the land involved in the proposal has done by me on dated 9/5/2023..... On inspection of the site, it is found that the land required by the user agency is 4.495 ha. forest Land In Bangai Reserved Forest and 0.451 ha. Protected Forest land along NH-28 (Gorakhpur to Kushinagar Road) and Gorakhpur- Pipraich Railway line with total area of **4.946** ha. Reserved /Protected forest land.

The requirement of forest land as proposed by the user agency in Part-1 of Form-A is unavoidable and rarest minimum required for the project.
