

SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF

(For the forest land to be diverted under FCA)

- 5.1 A proposal has been received by this office from Executive Engineer, CD PWD Dugadda for "Construction of 200m span double lane RCC with approach road on Been River of Chilla-Pushulok Motor road" under FCA-1980 of 0.51ha. of forest land non-forestry purpose. The Project envisages the use of, " Construction of 200m span double lane RCC with approach road on Been River of Chilla-Pushulok Motor road ". The site inspection of the land involved in the proposal has done by me on dated 10-10-2020.
- 5.2 On inspection of the site, it is found that the land required by the user agency is a Reserve Forest + Private Forest + Civil Forest (RF – 0.51 ha. + PF -0.00 ha.+CF – 0.00 ha. = 0.51 ha.
- 5.3 The requirement of forest land as proposed by the user agency in Col.2 part-I is unavoidable and is barest minimum required for the project. Yes
