

**FIELD INSPECTION NOTES OF THE SRI. Y. NARASIMHA RAO, SFS.,
DISTRICT FOREST OFFICER, JAGTIAL ON 24.07.2018.**

On 24.07.2018, I along with the Forest Range Officer, Metpally and the field staff are inspected the Reserved Forest area proposed for diversion of 2.0401Ha Forest land in RF for construction of 400 KV QMDC Line from STPP Jaipuram in Adilabad District to 400 KVSS Nirmal, Nirmal District under Nirmal Power Transmission Scheme in Jagtial District in lieu of diversion applied for the Project. The details are as follows.

The above said area is passing through Gannegutta R.F., Compt. No.401 to a length of 443.51 Mt. of about 46 Mtr. Width is uniform as mentioned above. The Canopy of this area is 0.2 to 0.3 and about 689 trees are required to be removed from the said area. The dominant species in the area are *Tectona grandis* (Teak), *Holoptelia integrifolia* (Namalinaru), *Azadirachta indica* (Vepa), *Wrightia tinctoria* (Palakodisa), *Chloroxylon swietenia* (Billudu), *Dalbergia paniculata* (Choppera), *Madhuca indica* (Ippa), Togar Mogilie, etc. enumeration and valuation of the tree growth in this area is completed and the list is enclosed.

I have searched for other alternatives, but there is no alternative land available except the present proposals. This is barest minimum area i.e., required for construction of 400 KV QMDC Line from STPP Jaipuram in Adilabad District to 400 KVSS Nirmal, Nirmal District under Nirmal Power Transmission Scheme in Jagtial District. No work is started as on date in violation of FCA, 1980. There are no encroachments and also no claims in the R.F. area that attracts the RoFR Act, 2006.

The User Agency has submitted their undertakings to implement the following conditions.

1. The User Agency shall construct boundary pillars separating the proposed area for diversion at every 20 Mtr. interval.
2. The Compensatory Afforestation is proposed in Compt. No.611/9 of Bandalingapur R.F. of Bandalingapur Beat & Section of Metpally Range.
3. The NPV of Rs.12.771 Lakhs shall be paid by the User Agency.
4. The project cost of Rs.97.7688 Lakhs shall be paid by the User Agency.
5. The area is free from encroachments and does not fall in Wildlife Protected area, Archeological heritage site, important monuments, there are no claims pending under RoFR Act, 2006. There are no endangered species that are caused or harmed due to construction of 400 KV QMDC Line from STPP Jaipuram in Adilabad District to 400 KVSS Nirmal, Nirmal District under Nirmal Power Transmission Scheme in Jagtial District.
