**13) Specific recommendation of DCF for acceptance or Other-wise of proposal with reasons.**

The proposal is recommended for acceptance; as the proposed forest lands is use for laying underground OFC duct & cable within ROW of existing road passing through forest land in Wavarhire, Shinganapur, Tal. -Man & Village - Wadale, Andrud, Tal. – Phaltan, Dist. Satara. The road selected as the maximum area will be covered for mobile network and also easy maintain for long period.

Proposal is recommended for C.A. may not be levied to this proposal, as proposal for laying underground OFC, within RoW of existing road, Area not falling in N.P. & WL.Sanctuary, & there is no need of felling of trees.( fulfils the conditions laid by MoEF &CC guideline FC- 11/165/2019 Dt 27/07/2020) Authority has not started work in forest land and also in Non-Forest land. P. A. will start work after sanction by State Govt.

There is no alternative non-forest land available and the area is to be diverted is not sensitive and hence will not have any adverse effect on the ecology of area. Hence this proposal is recommended for diversion of the forest land for laying of underground OFC Cable.
