A Proposal has been received by this office from Public Work Department, National Highway Division, Gaziabad (UP) for Diversion of 0.93 Ha. forest land (0.33Ha.PF+0.60RF) for Improvement and Upgradation of Newly declared National highway in the State of Uttar Pradesh. The Stretch starts from km 0+000 at Khada Chowk (Junction between Delhi-Roorkee road and Purquazi-Laskar Road (MDR 6W) Mukhiya Market in the District of Muzaffarnagar (New NH-334A) and ends at Km 15.089 under (FCA-1980) and use of 0.93 ha. (0.33Ha.PF+0.60RF) Forest Land of Protected and Reserve forest land for non-forestry purpose. The Project envisages the use of 0.93 ha. (0.33Ha.PF+0.60RF) forest land for for Improvement and Upgradation of Newly declared National highway 334A in Village – Dhamat and Sherpur, Tehsil and Disst. Muzaffarnagar.
