

**SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF
(for the forest land to be diverted under FCA)**

5.1- A proposal has been received by this office from- अधिशासी अभियन्ता उत्तराखण्ड पेयजल निगम देहरादून (under FCA -1980) of- **0.767 ha.** of forest land non- forestry purpose. The projects envisage the use of forest land for जनपद देहरादून के विकास खण्ड सहसपुर के अन्तर्गत ग्राम गलजवाड़ी में गलजवाड़ी पेयजल योजना के निर्माण हेतु वन विभाग (मसूरी वन प्रभाग के अन्तर्गत 0.158 है० एवं देहरादून वन प्रभाग के अन्तर्गत 0.522 है०) कुल- 0.767 है० वन भूमि का पेयजल निगम को हस्तान्तरण। मसूरी वन प्रभाग के अन्तर्गत हस्तान्तरण हेतु प्रस्तावित वन भूमि का विवरण :
