  - viii) Brief Note on vulnerability of the forest Area to erosion : The area proposed under this proposal is 0.335 Ha. for widening and strengthening of Ravulapally - Maddur Road from Km.3/2 to 4/2 (1 Km) passing through Doultabad Forest Block of Kodangal Range of Mahabubnagar Division. The Forest Area is degraded and the proposed project will have minimal impact on the adjoining Flora & Fauna.
  - ix) Approximate distance of proposed site for diversion from boundary of forest : The area proposed is for widening and strengthening of Ravulapally - Maddur Road from Km.3/2 to 4/2 (1 Km) passing through Doultabad R.F of Kodangal Range of Mahabubnagar Division.

The Forest Range Officer, Kodangal stated that on 09.09.2015 while verifying the proposals on field, it was observed that the R&B Officials and Contractor started the widening work for trench and filling with 400 mm thickness of metal. Immediately, the Forest Range Officer, Kodangal directed the R&B Officials to stop the work and shall not be carried out until environmental clearance under Forest (Conservation) Act, 1980 is approved. For this violation, the FRO, Kodangal issued a Show Cause Notice vide Rc.No.73/R&B/KDL/2015, Dt.9.9.2015.
- 10 Details of compensatory afforestation scheme. : Since the area proposed for diversion is 0.335 Ha. (Which is less than 1.00 Ha). Hence no C.A is proposed.
- i) Details of non-forest area/degraded forest area identified for compensatory afforestation, its distance from adjoining forest, number of patches, size of each patch. : The proposed land diversion site is 0.335 Ha. (Which is less than 1 Ha). Hence non forest land is not required.

Diversion of 0.335 Ha of Forest-Land in Compt.No.308 of Doultabad Forest Block area of Gokafaslabad Beat of Kodangal Range, Mahabubnagar Forest Division for widening and strengthening of Ravulapally – Maddur Road from Km.3/2 to 4/2 in favour of Executive Engineer (R&B) Division, Mahabubnagar will not have any erosive impact on Forest Area.
