

But wild animal like Sloth Bear, Bison, Python, King Cobra, Sambar, Deer, Barking Deer, Green Pigeon, Jungle fowl and Hyena are noticed around the applied area. Also, there is frequent movement of wild elephants in the proposed area for diversion & wild elephants are staying in that area for the whole year. Except that, some snakes and Birds are also seen in the proposed area.
