A Proposal has been received by this Diversion of 0.0892 Ha. of forest land in favour of Siwani Water Services Division Bhiwani for Deforestation from RD 0 to 10000, 11500 to 15000 & RD 16500 to 19000 on Bidola Minor in the work of remodeling of Bidola from RD 0 to 24600 having Chronic Tails to feed, Distt. Bhiwani under Forest Division Bhiwani. The site inspection of the land involved in the proposal been done by me on dated 16-06-2022 along with Division Bhiwani.

- 1 On inspection of the site, it is found that the land required by the user agency is a forest area Measuring 0.892 **ha**. The project involving Diversion of forest land in favour of Siwani Water Services Division Bhiwani for Deforestation from RD 0 to 10000, 11500 to 15000 & RD 16500 to 19000 on Bidola Minor in the work of remodeling of Bidola from RD 0 to 24600 having Chronic Tails to feed, Distt. Bhiwani under Forest Division Bhiwani.
- 2 The requirement of forest land as proposed by the user agency in Col. 2 of part-1 is unavoidable and is barest minimum required for the project.
