A proposal has been received by this office from M/S Wave Distilleries and Breweries Limited Industry for diversion (under FCA-1980) of 0.0545006 ha. of forest land for non-forestry purpose. The Project envisage the use of forest land for Construction of approach road to M/S Wave Distilleries and Breweries Limited Industry located on Aligarh-Ramghat Road Km 17 (Chainage 16.433 to 16.680) (RHS) at Khasra no. 211, 425Kh, 426, 436, 437, 438, 439, 440, 162A, 162B, 80, 81, 121A, 122, 31 Mi, 70, 73, 74, 77, 78, 121B, 123, 157, 156, 453, 457, 460 and 477, Village- Ahmedpura, Tehsil- Atrauli, District- Aligarh. The site inspection of the land involved in the proposal has been done by me on dated 18/03/23.

On inspection of the site, it is found that the land required by the user agency is a Protected Forest measuring 0.0545006 ha.

The requirement of forest land as proposed by the user agency in Col. 2 of part-I is unavoidable and is barest minimum required for the project.
