The Deputy Conservator of Forests, Jawhar has submitted the proposal mentioned in the subject vide his letter No. A/20/Land/FCA/955, dated 20.10.2022. Xerox copy of the same is enclosed herewith for your ready reference. The Project Authority of this project is Executive Engineer, MSETC Ltd., E.H.V. Projects Division, Kalyan - 421 301.

2.00 The Project Authority has highlighted that the said project is required in order to meet the present and future load demand of this area.

The said proposal is approved by Maharashtra State Electricity Transmission Company Ltd., Mumbai and sanctioned vide letter No. MSETCL/CO/Project-Scheme/Scheme-I/12696, dated 05.12.2018.

Therefore, the Project Authority is seeking Government of India's permission u/s.2 of Forest (Conservation) Act, 1980.

3.00 The Proposed Forest land required for this Project is 12.7435 ha. The details are as given below :-

- 4.00 The Project Authority has given an undertaking to pay the cost of Net Present Value as directed by the Government of India. The Project Authority has submitted necessary Certificates / Undertakings and Maps, which are also enclosed in the proposal.
- 5.00 The Deputy Conservator of Forests, Jawhar has certified that the proposed area for diversion of 12.7435 ha. Forest Land for use of non-forest purpose under Forest (Conservation) Act, 1980 for Forest land involved towards construction and laying 22 KV LILO M/C Transmission line on 220 KV Padghe-Wada transmission line at LOC No.97 for 220 KV Abhitghar Substation passing through Palghar Districts is about 1.608 Km. from the boundary of Tansa Wildlife Sanctuary. The proposed project is within 10 Km. of Tansa Wildlife Sanctuary and the project will not have any adverse effect on the Wildlife within National Park / Sanctuary. Further certified that the proposed area is not included in the area of any National Park / Wildlife Sanctuary or Nature Reserve.
- 6.00 Since the proposed Project is within 10 Km. from the boundary of Tansa Wildlife Sanctuary, the said Project is to be treated as in deemed Eco-Sensitive Zone of Tansa Wildlife Sanctuary as Eco-Sensitive Zone of Tansa Wildlife Sanctuary has not yet been finally notified.
- 7.00 The Deputy Conservator of Forests Jawhar has certified that the provisions of Forest (Conservation) Act, 1980 and guidelines under it have not been violated in the Project.
- 8.00 The Deputy Conservator of Forests Jawhar has certified that there is cutting and felling of 6311 number of trees in the project for diversion of 12.7435 ha. in the District of Palghar. Number of trees to be felled Girth wise are as under, breakup and felling estimate enclosed in the proposal.

- 9.00 The Project Authority has given undertaking that the process of getting FRA-2006 certificate from Collector, Palghar is in progress and will be submitted as and when receives from the Collector Palghar.
- 10.00 The Deputy Conservator of Forests, Nanded has proposed 26.00 ha. Degraded forest land of Reserved forest of Range Mahoor, Village Tandla, Survey/Gut No.11, Comptt. No.18, area 10.00 ha. and Range Degloor, Village Rurdrapur, Survey/Gut No.64, Comptt. No.588, area 16.00 total 26.00 ha. Further certified that proposed degraded forest land is suitable for Compensatory Afforestation and Management purpose and also it is free from encroachment, 10 years Compensatory Afforestation Scheme is enclosed with the proposal along with requisite maps.

- 11.00 The Deputy Conservator of Forests, Jawhar has certified, that the proposed Project is not likely to affect any monuments site of culture, historical, religious, archeological or recreational importance.
- 12.00 The Deputy Conservator of Forests, Jawhar has carried out site inspection on dated 06.10.2022. The site inspection reports is enclosed in the proposal.
- 13.00 The Deputy Conservator of Forests, Jawhar's report is self-explanatory and this office agrees with the same.
- 14.00 This project is for diversion of 12.7435 ha. Forest Land for use of non-forest purpose under Forest (Conservation) Act, 1980 for Forest land involved towards construction and laying 22 KV LILO M/C Transmission line on 220 KV Padghe-Wada transmission line at LOC No.97 for 220 KV Abhitghar Substation passing through Palghar District in the State of Maharashtra which is infrastructure and public utility project. The Project Authority is ready to bear all the Government levies and as per the recommendation of the Deputy Conservator of Forests, Jawhar the Proposed is recommended for acceptance and necessary approval u/s.2 of Forest (Conservation) Act, 1980.
