The Deputy Conservator of Forests, Jawhar has submitted the proposal mentioned in the subject vide his letter No. A/20/Land/FCA/954, dated 20.10.2022. Xerox copy of the same is enclosed herewith for your ready reference. The Project Authority of this project is Executive Engineer, MSETC Ltd., E.H.V. Projects Division, Kalyan - - 421 301.

2.00 The Project Authority has highlighted that the said project is primarily to provide power to the present and future load demand. Working at present condition there is heavy load shedding of power in this belt. It is very essential to construct and operate 400 KV LILO M/C Transmission Line on 400 KV Padghe – Tarapur Line for 400 KV Kudus substation and sanctioned.

The project has been approved administratively by Government of Maharashtra Industry, Energy and Labour Department Mantralaya, Mumbai vide MBR No.126/04, dated 23.02.2018.

Therefore, the Project Authority is seeking Government of India's permission u/s.2 of Forest (Conservation) Act, 1980.

3.00 The Proposed Forest land required for this Project is 3.2752 ha. The details are as given below:-

- 4.00 The Project Authority has given an undertaking to pay the cost of Net Present Value as directed by the Government of India. The Project Authority has submitted necessary Certificates / Undertakings and Maps which are also enclosed in the proposal.
- 5.00 The Deputy Conservator of Forests, Jawhar has certified that the proposed area for diversion of 3.2752 ha. of forest land for construction and laying of 400KV LILO M/C Transmission Line on 400KV Padghe-Tarapur Transmission line for 400 KV Kudus substation through Thane & Palghar Districts in the State of Maharashtra is 7.551 Km from Tansa Wildlife Sanctuary. The proposed area for diversion is not included in the area of National Park / Wildlife Sanctuary or Nature Reserve.
- 6.00 Since the proposed Project is within 10 Km. from the boundary of Tansa Wildlife Sanctuary, the said Project is to be treated as in deemed Eco-Sensitive Zone of Tansa Wildlife Sanctuary as Eco-Sensitive Zone of Tansa Wildlife Sanctuary has not yet been finally notified.
- 7.00 The Deputy Conservator of Forests Jawhar has certified that the provisions of Forest (Conservation) Act, 1980 and guidelines under it has not been violated in the Project.
- 8.00 The Deputy Conservator of Forests Jawhar has certified that there is cutting and felling of 430 number of trees in the project for diversion of 3.2752 ha. in the Districts of Thane & Palghar. Number of trees to be felled Girth wise are as under, breakup and felling estimate enclosed in the proposal.

9.00 The Deputy Conservator of Forests, Nanded has proposed 7.00 ha. Degraded forest land of Reserved forest of Range Bhodhadi, Village Digras, Survey/Gut No.24, Comptt. No.264A & 264B. Further certified that proposed degraded forest land is suitable for Compensatory Afforestation and Management purpose and also it is free from encroachment, 10 years Compensatory Afforestation Scheme is enclosed with the proposal along with requisite maps.

10.00 The Deputy Conservator of Forests, Jawhar has certified, that the proposed Project is not likely to affect any monuments site of culture, historical, religious, archeological or recreational importance.

11.00 The Deputy Conservator of Forests, Jawhar has carried out site inspection on dated 06.10.2022. The site inspection reports is enclosed in the proposal.

12.00 The Deputy Conservator of Forests, Jawhar's report is self-explanatory and this office agrees with the same.

13.00 This project is for diversion of 3.2752 ha. forest land for construction and laying of 400KV LILO M/C Transmission Line on 400 KV Padghe - Tarapur Transmission line for 400 KV Kudus substation through Thane & Palghar Districts in the State of Maharashtra which is infrastructure and public utility project. The Project Authority is ready to bear all the Government levies and as per the recommendation of the Deputy Conservator of Forests, Jawhar the Proposed is recommended for acceptance and necessary approval u/s.2 of Forest (Conservation) Act, 1980.

14.00 Four sets of proposals are enclosed herewith with all required documents for further necessary action. Proposal is submitted online vide No. FP-MH/TRANS/153218/2022.
