The applicant has submitted a proposal referred to above seeking prior approval of Central Government under Forest (Conservatiuon) Act, 1980 in pursuance of Urban Development Department Notification No. TPS 2496-1505-CR-273-UD-9 dated 6/5/2000 read with Notification No. TPS-2402-313-CR-137-UD-9 dt. 30/6/2003 sanctioning the Regional Plan for Nagpur District are earmarked th said survey no. 88 of Village Tarodi (Bu.) for Transport City & Industrial Estate user in the said Regional Plan.
