

Site Inspection Note

Sub :- The Project Site for Retail Outlet of M/S IOCL located at Khata No- 81 Plot No- 825 & 826, Thaana No- 617, Mouza- Eru, Thana- Wazirganj, Distt- Gaya on NH- 82 Gaya-wazirganj-Hisua-Nawada road was inspected on 10.09.2021. The representatives of the user agency were present during the time of inspection.

The instant project site was proposed for diversion of forest land (linear) for making entry and exit passage to Fuel Pump of IOCL by the applicant dealer Smt. Mina Sharam, W/o- Late Sharwan Kumar At- Lakhibagh, Manpur, Buniyadganj, Distt- Gaya. The important point of site inspection report are :-

1. The proposed project requires land for entry and exit of vehicles for the proposed IOCL retail outlet, which has to pass through the linear Protected Forest along the NH-82 Gaya-Wazirganj-Hisua-Nawada road, which was notified as vide Environment, Forest and Climate Change, Government of Bihar's notification no. S.O- 400 dated- 31.12.1996.
2. The forest area required for the project is 0.01125 Ha. The proposed site is barest minimum required for the proposed project.
3. The undersigned concurs with the report and recommendation of the concerned Deputy Conservator of Forest, Gaya Forest Division, Gaya.
4. The proposal may be sanctioned subject to the condition of payment of amount for compensatory afforestation by the User Agency.
