13	Specific recommendations of the DCF for acceptance or otherwise of the proposal with reasons	:	<p>The diversion of forest land is proposed for development of road, which connects the Guntapally Cheruvu Thanda which is an enclosure in the R.F. to the Yellareddipet to Veernapally Road. It is noticed that it is only proposed road to connect the said village. Since the road is passing through the forest area and there are many turnings/curves, the user agency shall also ensure laying the speed breakers along the road to avoid accidents to wildlife and also the human beings.</p> <p>Hence it is recommended for diversion of 2.3091 Ha. of forest land in Compt. No. 158, 159 &amp; 160/ Almaspur beat / Gollapally Section / Sircilla Range in Sircilla R.F. for formation of road from Almaspur to Guntapally Cheruvu Thanda.</p>
