Specific recommendations of the DCF for acceptance or otherwise of the proposal with reasons

The diversion of forest land is proposed for development of road, which connects the Maddimalla village to Gundaram Village. The said proposed road shortens the distance between these two villages. Old cart tract is existing and now they have proposed for widening and laying B.T. The said road passes through dense forest area having good vegetation and the terrain is also hilly. Since the road is passing through the forest area and there are many turnings/curves, the user agency shall also ensure laying the speed breakers along the road to avoid accidents to wildlife and also the human beings. It is also proposed for installation of check post at Gundaram village shivar in the Forest and also placing (02) numbers Check post watchers at the cost of user agency for (10) years to control the timber smuggling. An estimated cost of Rs. 50.00 Lakhs is proposed and the detailed annual estimated cost is enclosed.

Hence subject to above conditions, it is recommended for diversion of 3.9005 Ha. of forest land in Compt. No. 149/ Maddimalla South beat / Veernapally Section Compartment No. 156 / Gollapally Beat/ Gollapally Section/ Compartment Thimmapur Beat/Gollapally Section/ Sircilla Range Sircilla R.F. for formation and laying of B.T. road from Maddimalla Village to Gundaram Village.
