It is submitted that, the Director of Mines and Geology, Vijayawada in reference 1st cited, has forwarded the proposal for diversion of 4.82 ha of forest land falling in Compartment no.227 of Basavapalli RF, Chittapara Beat, Chittoor West Division & Chittoor District in favour of M/s. Sri Vaishnavi Granites (Proprietor: Smt. Edavlli Akhila) for grant of quarry lease for Black Granite.

While forwarding the application, the Director of Mines and Geology, Vijayawada in the reference 1st cited has furnished the following information.

- The Black Granite found in the proposed forest land is very rare in variety and unique. It displays pearly sheen against dark green back ground which is not yet identified in any non-forest lands.
- The proposed area is situated in Compartment no.227 of Basavapalli RF and the area is situated 505 m to Naraharipet Village of Gudipala Mandal as crow fly distance which is nearer to location.
- The proposed area is not overlapping with any other user agencies or forms part of VSS area and it is free from legal cases.

Further, in the reference 4th cited, the Director of Mines and Geology, Vijayawada has submitted additional information as sought by this office, which is as follows;

1. Details of alternative explored along with map;

The Director of Mines & Geology, A.P., Ibrahimpatnam has submitted that, generally the Black Granite (Dolerite Dyke) occurs as intrusive body in the peninsular gnessic complex. The East - West trending dykes are productive in this sector. The Black Granite found in the proposed forest land is very rare in variety and unique displays pearly sheen against the green back ground which is not yet identified in any non-forest lands. The Black Granite available in this area is being marketed as G-20 and exported to Italy, Taiwan and Germany and fetches good revenue to Government. As per as Granite mineral concern, the nature of deposition, structure and other features influence the recovery of dimensional stone and commercial viability. Further it is observed that particular quality of black granite available in Basavapalli and Chittapara RFs is not available in any revenue lands and patta lands. This G-20 variety in Black Granite is not available anywhere in the State except Chittoor District. The quality and use of granite depend upon it granularity, colour, presence of structural elements, inclusion, brittleness, chemical and mineralogical composition and hence we can't compare with other granite varieties available in other places and also there is not alternative granites to G-20 variety.

The Proprietrix, M/s. Sri Vaishnavi Granites, Hyderabad has initiated a proposal in the Ministry's web portal on 23.02.2021 and the proposal is registered with unique no.FP/AP/QRY/121190/2021.

The proposal was forwarded to the Divisional Forest Officer, Chittoor West in the Parivesh portal for processing the proposal as per the Forest Conservation Rules, 2003 and the guidelines issued by Gol, MoEF&CC, New Delhi under the Forest (Conservation) Act, 1980.

The Chief Conservator of Forests, Ananthapuramu in the references 3rd cited has submitted Part-II & III proposals and additional information in the reference 5th cited.

The details of the proposal is as follows;

The User Agency has furnished the following information in Part-I:

- For locating the project in forest area, the User Agency has justified that, Geologically the applied area belongs to peninsular genesis complex essentially a low grade metamorphic terrain formed during Archean times and are intruded by late Archean to early proterogenic mafic dyke swarms. The applied area consists of dolerite dyke striking NW-SE in direction. The width of the dyke is about 80 to 100 m. and length is 375 to 400 m. The applied area is covered with small boulders ranging from 1.5 to 4 m. underneath by sheet rock. Mineralogically the dolerite consists of plagioclase feldspar and augite as essential mineral and olivine, chlorite and quartz as accessory mineral. Petrology of the area constitutes and exhibits wide variation in their external forms, structural patterns with preferential emplacement broadly along East-West Direction. At some places the dyke is swelling and pinching. The unaltered part of plagioclase is cloudy due to minute inclusions of magnetite which is a common feature of dolerite dyke intrusive into granulite terrain. The rock available in that area is hard, compact in structure and black in colour. The above factors are commercially viable and may attract export value. Structurally the rock units are joined and influence in recovery of dimensional stone.
- The user Agency has furnished the DGPS authenticated maps for the area proposed for diversion and CA land respectively.

- There will be no displacement of people due to this project.
- The User Agency has submitted that the employment likely to be generated due to this project is 4 number of persons (Permanent) and 1600 number of person-days (Temporary).
- The user agency has indicated the safety zone area for the proposed mining project in the authenticated DGPS map.
- The User Agency has submitted undertakings to bear the cost of raising and maintenance of compensatory afforestation in the identified CA land, payment of N.P.V., cost of tree extraction charges as decided by the Forest Department. And also to bear the cost of protection and regeneration of safety zone area and also to bear cost of afforestation the degraded forest land one and half times of forest area under safety zone.
- The user agency has identified non-forest land for compensatory afforestation over an extent of 4.95 ha in Sy.no.103-2 of Ramagiri Village, Ramagiri Mandal, Ananthapuramu District.

The Divisional Forest Officer, Chittoor West has furnished the following information in part-II:

- Site inspection was conducted by the DFO, Chittoor West on 04.06.2021.
- Area of the forest land proposed for diversion is as follows.

- Basavapalli RF is notified U/s 16 of Madras Forest Act, 1882 vide Notification no. 367, dt. 21.08.1891.
- Density of vegetation is 0.5.
- 237 nos. trees are to be felled in the proposed diversion area.
- The flora existing in the proposed area are Albizzia amara (Chigara), Dichrostachys cinereaa (Veluthuru), Azadirichta indica (Vepa), Strychonus nux vomica (Musti), Holoptelea integrifolia (Nemallinara), Morinda tomentosa, Excocaria agallocha (Chilla), Wrightia tinctoria (Reppala), Cassia fistula (Rela) etc.
- The proposed area is covered with thorny bushes and huge boulders. The surrounding area is prone to soil erosion. SMC measures are to be taken up with planting on mounds of SMC structures.
- The proposed mining area is approximately at a distance of 10 m from the nearest RF boundary (which is estimated by using GIS (Arc view) technology).
- The proposed area for diversion does not fall under National park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve and elephant corridor etc.,
- There are no rare / endangered / unique species of flora and fauna found in the proposed diversion area.
- There are no protected archaeological/heritage site/defense establishments or any other important monuments are located in the area.
- The forest land required for diversion is the barest minimum.
- No violations were taken place in the proposed area by M/s. Sri Vaishnavi Granites, Hyderabad.
- Non-forest land to an extent of 4.95 ha has been identified in Sy.nos.103-2 Village, Ramagiri Ramagiri Mandal. Ananthapuram Ananthapuram District. The non-forest land identified by the user agency is adjacent to the CA land taken over by the Forest Department. The CA land is having natural miscellaneous growth with the species like Albizia amara (Chigara), Acacia sundra (Sundra) and Phoenix sylvestris (Eatha) and the site is suitable for SMC works like check dams, MPTs, CCTs and gap planting and wild animals like Black buck, Peacock, Deer are existing in the location. Further, as the non-forest land identified by the user agency for CA is not suitable for planting since it is already covering with natural tree growth, it is proposed to take up CA plantations over an extent of 4.82 ha in the degraded forest land in Compartment no.420 of Ramagiri West RF & Beat which is equivalent to area proposed for diversion. The DFO, Chittoor West has submitted authenticated map of the degraded forest land identified for raising CA and it is uploaded at Nodal Officer level.
- Compensatory Afforestation scheme proposals for treatment of non-forest land of 4.95 ha identified in Sy.no.103-2, Ramagiri (V) & (M),

Ananthapuramu District and raising CA plantations in the degraded forest land identified over an extent of 4.82 ha in Compartment no. 227 of Basavapalli RF, Chittoor West Division, has been prepared for Rs.38.100 lakh from the year 2022-23 to 2033-34. Since it is not uploaded at Part-II, the same has been uploaded at Nodal Officer level.

- The Scheme for fencing, protection, regeneration of safety zone area and for raising and maintenance of enrichment plantation over an extent of 1.20 ha in degraded forest area in Compartment no.241, Vovilathota RF, Santhapeta Beat, Chittoor West Range in lieu of safety zone area of 0.80 ha, has been prepared with an outlay of Rs.4,76,000/-(one and half times of the safety zone area safety zone area proposed for diversion is 0.80 ha.). The DFO, Chittoor West has submitted surveyed sketch of safety zone afforestation in Compartment no.241, Vovilathota RF, Santhapeta Beat, Chittoor West Range which is not uploaded in Part-II and the same is uploaded at Nodal Officer level.
- RoFR certificate in Form-II as prescribed under the Forest (Conservation) Act, 1980, issued by the District Collector, Chittoor District was furnished.
- Statement showing the calculation of Net Present Value in the proposed area for diversion is detailed below.

It is further submitted that, the DFO, Chittoor West has submitted Mining Plan approved by the Deputy Director of Mines & Geology, Chittoor in Rc.no.122/MMP/BG/CTR//2022, dt.27.01.2022 for a period of (5) years. In the mining plan, at Sl.no.3 of Progressive Mine Closure Plan (page no.22 & 23 of the modified mining plan), the Deputy Director of Mines & Geology, Chittoor has stated that, by the end of first (5) years plan period about 0.9723 ha of mining block would be used for mining including for site services & internal roads. Balance mining block area of about 0.8873 ha would be used for waste dumping including retaining wall and garland drain. By the end of the life of mine about 2.1240 ha would be used for mining activity and 1.5752 ha will be used for waste dumping purpose. No back filling is proposed in this lease period because the mineral available at the bottom to be excavated in the next lease period. The Deputy Director of Mines & Geology, Chittoor has also stated that, the land use pattern for the first (5) years plan period and remaining life of the mines, as below.

In the light of the provisions contained under the Forest (Conservation) Act, 1980, it is mandatory to raise Compensatory Afforestation Plantation in lieu of forest area proposed to be diverted. The user agency i.e., M/s Sri Vaishnavi Granites, Hyderabad, has identified non-forest land for C.A., over an extent of 4.95 ha in Sy. No. 103-2 of Ramagiri village of Ramagiri mandal of Ananthapuramu Range in lieu of diversion of 4.82 ha (Mining & dumping – 3.70 ha, Safety zone – 0.80 ha & Road – 0.32 ha) of forest land in Compartment No. 227 of Basavapalli RF, Chittapara beat of Chittoor West Division, Chittoor District for grant of quarry lease for black granite.

The non-forest land identified by the user agency i.e., 4.95 ha is having natural miscellaneous growth and suitable for taking up SMC works like Check dams, MPTs, CCTs and Gap planting etc.,

Since, the non-forest land identified by the Use agency for C.A. is not suitable for planting, it is proposed to take up C.A. plantation over an extent of 4.82 ha in degraded forest land in Compt. No. 420 of Ramagiri West RF & beat which is equivalent to forest area proposed for diversion.

AREA:-

Since, the non-forest land identified by the Use agency for C.A. is not suitable for planting, it is proposed to take up C.A. plantation over an extent of 4.82 ha in degraded forest land in Compt. No. 420 of Ramagiri West RF & beat which is equivalent to forest area proposed for diversion. The C.A. plantation in degraded forest land and treatment of non-forest land will be taken up with the funds deposited by the user agency. The degraded forest land proposed to be treated for C.A. is suitable for raising of plantation with species like *Hardwickia binata*

(Narepi), <u>Holptelia integrifolia</u> (Thapasi), <u>Azhadiracta indica</u> (Neem), <u>Pongamia binnata</u> (Kanuga), Ficus species & other miscellaneous species.

OBJECTIVE :-

The main objective of the scheme is to compensate the loss due to the diversion of Forest Land and to afforest the area and protect the soil to prevent soil erosion besides encouraging ecological balance.

Scheme Proposals:

Activities proposed for treatment of non-forest land (4.95 ha)

The following activities are proposed for treatment of non-forest land over an extent of 4.95 ha in Sy. No. 103-2 of Ramagiri village of Ramagiri mandal of Ananthapuramu Range of Ananthapuramu District.

Treatment of degraded forest land (4.82 ha)

Technique:

It is proposed to raise the plantation by adopting the Labour Intensive Method over an extent of 4.82 ha in degraded forest land in Compt. No. 420 of Ramagiri West RF & beat with excavating the 0.45 M x 0.45 M x 0.45 mt size pits at 3 M x 3 M espacement. Tall plants of one meter and above height raised in 8" x 12" size bags will be planted. Basal dressing with Super phosphate @ 50 grams per pit and DAP @ 20 grams per pit will be done in the pits after planting. Circular weeding cum soil working is also proposed. Watering to the plants for 10 times during the non-rainy days is proposed. Fire tracing operations will also to be taken up. The plantation will be maintained for (10) years after raising.

PROJECT PERIOD:-

It is proposed to implement the scheme from 2022-23 to 2033-2034 over a period of (12) years.

FUNDING AGENCY:-

The total financial outlay will be met by the User Agency i.e., M/s Sri Vaishnavi Granites, Hyderabad who will deposit the funds with the Forest Department.

EXECUTIVE AGENCY:-

The Forest Department will be the implementing Agency for this scheme.

FINANCIAL OUTLAY :-

For treatment of 4.95 ha of non-forest land identified by the user agency i.e., M/s Sri Vaishnavi Granites, Hyderabad in Sy. No. 103-2 of Ramagiri Village of Ramagiri mandal of Ananthapuramu Range of Ananthapuramu District and also Raising of Plantation in degraded forest land in Compt. No. 420 of Ramagiri West RF & beat under Labour Intensive Method over an extent of 4.82 ha, an amount of Rs. 38.10 Lakh is required. The User Agency i.e, M/s Sri Vaishnavi Granites, Hyderabad has to deposit the Compensatory Afforestation amount, which will be utilized for Raising Compensatory Afforestation plantation in degraded forest land over an area of 4.82 ha and treatment of 4.95 ha of non-forest land identified by the user agency.
