<p><b>14.</b> Whether site, where the Forest Land involved is location has been inspection by the concerned Chief Conservator of Forests (Yes/No) if, yes. Date of inspection &amp; observations made in the form of inspection note to be enclosed.</p>	<p>The proposal 33 KV T/L from Namsai to Diyun is conceived under GOI project namely "Comprehensive Scheme of Transmission and Distribution in Arunachal Pradesh (a Central Govt. Project funded by GoI). As the total area involved in this division is 11.61 Ha so it has not been inspected.</p> <p>The route alignment of 33 KV T/L falling under Nampong FD Jairampur under Changlang District has been stated to be passing along the road and mostly open areas hence the density of the vegetation has been stated to be 0.4 to 0.5% by DFO Nampong, Jairampur. The total number of Poles below 60 cm likely to be felled is 12 while the timber size trees above 61 cm girth likely to be felled is 140 totaling to 152 as per enumeration list submitted by DFO Nampong FD Jairampur and also mentioned by him at SN 6 of his inspection report dt. 18/02/2021. The figure of 23152 mentioned at SN 6 includes 15000 Jati Bamboo and 8000 Toko leaves together with 152 trees and poles totaling to 23152 as per abstract of enumeration list submitted by him.</p>	SN	District	Forest Division	Break up of Forest Area Involved in Ha. 		<p>As regards CA, the DFO Nampong has identified an area of 24.0 Ha (against 11.61 Ha. of forest land proposed to be diverted) in Nampong FD Jairampur in Diyun RF under Diyun Forest Range and has submitted map of proposed 24 Ha CA area. However the suitability certificate given by DFO Namsai is for equivalent area i.e. 11.61 Ha for which DFO Nampong is being directed to submit a revised suitability certificate for 24.0 Ha along with geo-coordinates if such land is actually available and suitable for CA. The MDF/VDF etc category may please be checked on GIS platform which is not available in this office.</p>
15.	Whether the concerned Chief Conservator of Forests agree with the information of Deputy Conservator of Forests.	Yes, I agree except the information which has been specifically corrected and mentioned at SN 14 above.
16.	Specific recommendation of concerned Chief Conservator of Forests for acceptance or otherwise of the proposal with detailed reasons.	Since the proposed 33 KV T/Line is an integral part of a comprehensive scheme for better and uninterrupted power supply and distribution in the State so the diversion of 11.51 Ha of forest land in Jairampur Forest Division in Changlang Forest Division for construction of 33 KV transmission line from Namsai to Diyun is recommended.
