### **SITE INSPECTION REPORT OF DEPUTY CONSERVATOR OF FOREST, JODHPUR FOR THE FOREST LAND TO BE DIVERTED UNDER FCA**

The Proposal has been received by this office for diversion (under FCA 1980) of 0.4707ha. Forest land for non forestry purpose. The subject envisages the use of forest land for of Optical Fibre Cable along the Phalodi - Pokaran Road (NH-11) from Phalodi BSNL Telephone exchange to Beethadi Gram Panchayat under NOFN Project (Chainage 0.00 to 14.040 kms), Tehsil-Phalodi, Jodhpur. The site inspection of the land involved in the proposal has been done on 25.11.2020 along with forest staff.

On inspection of the site, it was found that the land required by the user agency is forest land measuring **0.4707ha.**for laying OFC Cable line. It is lying in the Range Phalodi and legal status of the land is **Protected forest Block- Phalodi.**

The requirement of forest land as proposed by the user agency in part-I is unavoidable and is barest minimum required for the project. All possible alternate route has been explored and no other feasible route except this.

There is no any rare/endangered/ unique species of flora and fauna found in the area.


There is no any protected archaeological/heritage site/defense establishment or any other important monument is located in the area.

**It has been found that the user agency has NOT violated the forest (Conservation) Act, 1980 provision till date and no work has been started without prior permission.**
