


निरीक्षण प्रतिवेदन

कार्यपालन यंत्री जलसंसाधन विभाग संभाग खण्डवा, द्वारा ऑनलाईन प्रस्ताव क्रमांक FP/MP/IRRIG/29552/2017 में आंवलिया मध्यम सिंचाई परियोजना हेतु प्रस्तावित स्थल का निरीक्षण मेरे द्वारा दिनांक 18/11/2017 किया गया है। परिक्षेत्र पूर्व कालीभीतम कक्ष क्रमांक 513 ए.बी रकबा 54.60 हेक्टेयर वनभूमि प्रभावित होगी। परियोजना से प्रभावित वृक्षों की संख्या 416 है। अन्य कोई विकल्प नहीं है। वनग्राम आंवलिया के 30 हितग्राही प्रभावित होंगे। प्रत्यावर्तित वनभूमि के बदले में उपलब्ध कराई जा रही गैरवनभूमि ग्राम सुरगांव निपानी खसरा नम्बर 37,49,215 रकबा 54.60 हे. पर वर्तमान में 80 प्रतिशत भूमि पर अतिक्रमण है जिसे रिक्त करने हेतु कलेक्टर जिला खण्डवा को कार्यालयीन पत्र क्रमांक 3883 दिनांक 17.11.2017 द्वारा अनुरोध किया गया है। आंवलिया मध्यम सिंचाई परियोजना हेतु प्रभावित वनभूमि 54.60 हेक्टेयर के प्रत्यावर्तित करने हेतु आवेदक संस्था को उपयोग पर प्रदान करने की अनुशंसा की जाती है।


