13.	Specific recommendations of the DCF for acceptance or otherwise of the proposal with reasons.	Talangi-A Chromite mines of M/S IDCOL .is an ongoing mining project for exploration of Chromite ore confined within Mining Lease area of 65.683 Ha. The Mining Lease area comprises 20.881 Ha. of forest land and 44.802 Ha. of non-forest land. Accordingly the mining lease deed has been duly executed for 65.683 ha. and the mining operation is continuing under the provision of MMDR (Amendment) Act,2015. But as per Sabik Settlement record, 39.741 Ha. is forest land out of the total ML area of 65.683 Ha. The User Agency has already obtained forest clearance over 17.483 Ha. of forest land from MOEF, Govt. of India vide their Letter No.. 8-81/97 FC dt. 08.06.2001. The present proposal is for balance forest area of 22.258 Ha including safety zone area of 3.398 ha. Hence the proposal is recommended for acceptance.
