Nilgai is found naturally and free distributed across the Gaya district in the farmlands. Animals like jackal, hair, Common Langur etc are found in the nearest forest areas. The undersigned is of the opinion that the proposed project will not affect the distribution or movement of any wild animals found in the area. So far, no case of wildlife death has been reported on the proposed site. Nevertheless, the crop raiding Nilgai is present in the adjoining areas of the forest boundary.

As per my knowledge, the enquiry report of the Forest officials and the information provided by the user agency, there is no record of any protected archaeological/heritage site/defense establishment or any other important monument located in the area of the proposed project.

13. Specific recommendations of the DCF for acceptance or otherwise of the proposal with reasons.	<p>This is the bare minimum forest land required for the project. The amount realized from the user agency in the form of NPV shall be utilized for conservation, protection, and management of forest in this division. The green belt will be created through the amount realized from the user agency as Compensatory afforestation work and it will help in the increasing green cover.</p> <p>The proposed area involves diversion of 0.0175 Hectares in Gaya Forest Division, Gaya. This is the bare minimum of forest land required for the project and has no other alternative to bypass. Diversion of this forest land area for the project (Non-Forestry activity) may not much affect the local flora of the area. The User Agency has violated the prescribed provisions of the Forest Conservation Act and Indian Forest Act at the time of inspection. The earth works have been completed without getting work order from the Forest Department.</p> <p>In light of the above mentioned facts and keeping the cognizance that Gaya District falls under the Naxal Affected area and as per the prescribed provisions, I recommend positively for the approval of this proposal with Penal NPV provision. Therefore this proposal for diversion of forest land may be approved with necessary conditions and directions.</p>
