The User Agency is responsible for safe guarding the adjoining flora and fauna in the surrounding area. 2. The NPV value as applicable shall be paid by the user agency upon stage-1 approval for further process of the proposal. 3. The User Agency is requested to deposit Rs. 2,11,517/- to the Telangana Forest Department for the Extraction charges of the tree growth in the diversion area. 4. The user agency is requested to deposit Rs. 32.687 Lakhs to the Telangana Forest Department towards Compensatory Afforestation.
