

FIELD INSPECTION NOTES OF SMT. SUNITA M. BHAGWAT, IFS., ADDL. PRL. CHIEF CONSERVATOR OF FORESTS / CF, RANGAREDDY CIRCLE, RANGAREDDY IN SRINAGAR RF ON 24.11.2021

Proceeded to the Srinagar RF of Mankhal Range of Shamshabad Division of Rangareddy District accompanied by the District Forest Officer, Rangareddy, Forest Divisional Officer, Shamshabad and Forest Range Officer, Mankhal and other staff of Mankhal Range. Inspected the diversion area of 1.9716 ha of forest land in Shamshabad division for Erection of 132 kv overhead DC / SC line from 220 / 132 kv Fabcity to proposed 132/33 kv Kandukur Substation in favour of TS TRANSCO and noticed the following:

- a. The total length proposed line is 730.24 mtrs with a width of 27 mtrs passing through Srinagar RF of Mankhal Range.
- b. There are 337 no. of trees existing in the diverted area species consists of Cassia siamea, Dirshanam, Eucalyputs (Nilgiri), Pongamia pinnata (Kanuga), Terminalia alata (Maddi), Albizia amara (Narlinga), Holoptelea integrifolia (Nemalinara), Olasis, Wrightia rinctoria (Palakodisa), Cassia fistula (Rela), Acacia chundra (Sandra), Annona suqamosa (Sithaphal), Dalbergia Sissoo (Sissoo), Leucaena leucocephala (Subabul), Tectonia grandis (Teak), Acacia leucophloea (Tella tumma), Accacia Arabica (Tumma), Azadirachta indica (Vepa) & others out of which 231 nos are pole crops and balance of trees. The height of species varies from 1.5 mtrs to 6 mtrs.
- c. The trees have been enumerated up to 13.5 mtrs on both sides of the center of the towers having geo-coordinates from point C5 to C3 and shown on the map. The user agency has proposed other 3 towers all along the boundary wall of the Srinagar RF block to reduce loss of vegetation i.e., from point C3 to C1. Hence, the trees have been enumerated on one side up to 13.5 mtrs only while towards the boundary wall side it is only 5 mtrs width. The enumeration list of trees is enclosed.
- d. During the inspection it is found that no endangered / unique spices of flora and fauna found in the proposed area other than Wild boars enlisted in Schedule – III of Wildlife (Protection) Act, 1972.
- e. The proposed area is not falling in any National Parks, Wildlife sanctuary Biosphere Reserve, Tiger Reserve or Elephant Corridor.
- f. There are no protected archaeological / heritage site / defense establishment or any other important monuments is located in the area.
- g. No violation of Forest Conservation Act has been carried by the user agency in the proposed area.
