1. A proposal has been received by this office from Project Director NHAI, PIU , Dwarka, for diversion (under FCA-1980) of **10.00** ha. of forest land for non forestry purpose. The subject envisages the use of forest land for Construction and Development of Dwarka Expressway (NH-248BB) from Km 20, NH-8 (Near Shiv Murti, Delhi) to Km 40, NH-8 (Near Village Khirki Dola, Gurugram) in the NCT of Delhi:- Package-1 Shiv Murti to Delhi/Haryana Border (Km 0.000 to Km 5.300)
2. The site inspection of the land involved in the proposal has been done by me on 16.01.2019. On inspection of the site, it is found that the land required by the user agency is a Forest area measuring 10.00 ha.
3. The requirement of forest land as proposed by the user agency in Col. 2 of part-I is unavoidable and is barest minimum required for the project.
