Details of non forest area/ degraded forest area identified for compensatory afforestation its distance from adjoining forest, number of patches size of each patch : The User Agency has proposed 172.57 ha of non forest land of Village Mundhe Tarf.Sawarde Tal.Chiplun Dist.Ratnagiri for compensatory afforestation.But the Divisional Forest Officer,Chiplun has mentioned in his Suitability certificate that compensatory afforestation in the above area can not be taken as the area already has tree cover. The proposed land is acceptable as per Govt. of Maharashtra letter dt.27.08.2014 as the area is included in the Eco Sensitive Zone of Koyana Wild Life Sanctuary. Therefore the degraded forest land ( Zudpi Jungle) admeasuring 141.99 ha in this division is being proposed for taking actual compensatory afforestation.


