

FIELD INSPECTION NOTES OF Sri. U. KOTESWARA RAO, FOREST DIVISIONAL OFFICER, KHANAPUR ON DIVERSION OF 4.2063 Ha OF FOREST LAND IN KHANAPUR DIVISION FOR IMPROVEMENT AND WIDENING OF EXISTING R/F RASIMATLA TO KORIKAL VIA ANKENA, RAYADHARI ROAD PEMBI (M) , KHANAPUR DIVISION IN FAVOUR OF DISTRICT PANCHAYATH RAJ ENGINEER, NIRMAL ON 31.07.2020.

I along with the Forest Range Officer, Tandra and concerned Range staff of Tandra Range inspected the proposed area for diversion of Forest Land for improvement and widening of existing **"R/F Rasimatla to Korikal vai Ankena, Rayadhari Road of Pembli (M)"** in favour of District Panchayath Raj Engineer on 31.07.2020. The proposed area is falling in Rajura Reserve Forest Block and Mamada Reserve Forest block in the following 3 stretches.

1. From R 10 to R 75 alignment length is about 2306.12 Mtrs falling in Compt. No. 931 Rasimatla Beat, 806 Ankena Beat of Mamda Reserve Forest Block.
2. From R 80 to R 107 alignment length is about 1134.27 Mtrs falling in Compt. No 802 and 803 Pochampally (W) Beat of Mamda Reserve Forest Block.
3. From R 142 to R 264 alignment length is about 3569.98 Mtrs falling in Compt. No 780,781,& 783 Raidhari Beat of Rajura Reserve Forest Block.

The Mamada Reserve Forest Block is notified U/s.15 vide Gt. No. 1, Dt. 03-01-1355, and Rajura Reserve Forest Block is notified U/s.4 vide Gt. No. 626 F&RD (For.III) Dept, Dt. 24-9-1979. Total length of the proposed road passing in forest area is 7010.37 Meters and the proposed width is 6.00 Meters and total area required for diversion is 4.2063 Ha. The proposed area is falling in Kawal Wild life sanctuary Buffer zone of Tandra Range of Khanapur Division.





During the field inspection, it is noticed that, the alignment of road proposed for diversion is passing through the existing Road. Of the total proposed length of Road (7010.37) Right of way is admitted in 0.4 Km length from Rasimetla to Ankena with a width of 3.5 Mts. The remaining area is does not have any right way. No tree growth is existing in the proposed area for diversion. Hence no cutting of trees is required.

The said proposed area for diversion is falling in Kawal Wild life sanctuary. There are no protected Archaeological/ Heritage site/Defence establishment or any other important monument in the forest area proposed for diversion.

Thus, this improvement and widening of existing road from **R/F Rasimatla to Korikal vai Ankena, Rayadhari Road of Pembi (M)** in favour of District Panchayath Raj Engineer is **recommended** by considering all the aspects mentioned in the proposal and field conditions.
