## SITE INSPECTION REPORT

1. A proposal of PMGSY Division Chatroo is recommended by DFO Marwah in Parivesh Portal for diversion of Forest land under Forest conservation Act 1980 for non forestry purpose. The project envisaged diversion of 0.028 hac of forest land at Marwah Forest Division in District Kishtwar in favour of PMGSY Division Chatroo for construction of 40 mtr span Motorable Bridge over Synthen Nallah of Watsar to Dangar Nallah Road KM 2<sup>nd</sup> RD (140-190) in the UT of J&K in Marwah Forest Division. The site inspection of the spot involved in the proposal has been done by the Divisional Forest Officer Marwah on 08-03-2022.

- 2. No protected / heritage site /defence establishment etc is located in the area.
- 3. Project may not effect the survival of wild animal as the project is near the human habitation.
- 4. No violation of the Act has been carried out by the user agency as the work for this proposal is yet to be started which shall be allowed only after clearance of the proposal by competent authority.
- 5. Whether site, where the forest land involved is located has been inspected by concerned Conservator of Forests (No).
- 6. Whether the concerned Conservator of Forests agree with the information given in Part-B and the recommendations of Divisional Forest Officer (Yes).

## SPECIFIC RECOMMENDATION:-

The proposal may be accepted as per guideline of Govt. of India as the Forest land proposal for diversion of 0.028 hac of Forest land is essentially required for construction of 40 mtr span Motorable Bridge over Synthen Nallah of Watsar to Dangar Nallah Road KM 2<sup>nd</sup> RD (140-190) in the UT of J&K of Marwah Forest Division. As the proposal recommended for forest clearance under section-2 of Forest Conservation act, 1980. The construction of Bridge over synthen Nallah of Watsar to Dangar Nallah road is essentially required for smooth vehicular movement and presentably the said road is connected with culvert which is not suitable for vehicular movement. Submitted by Divisional Forest Officer Marwah is recommended to be accepted.
