A proposal has been received from SIKAR NEW TRANSMISSION LIMITED (A 100% WHOLLY SUBSIDIARY OF POWERGRID CORPORATION OF INDIA LIMITED) for diversion (under FCA-1980) of 7.5486 ha. of Protected forest land of Village-Khadag bijure, Naathuwala (Dokan) Forest block-Ganwari, Range Neemkathana & Patan, Division Sikar for non forestry purpose. The subject envisages the use of forest land for Diversion of 7.5486 ha. of forest land for Construction of "CONSTRUCTION OF SIKAR-II-NEEMRANA 400 KV D/C TRANSMISSION LINE(TWIN HTLS) DISTRICT-SIKAR, JHUNJHUNU, JAIPUR & ALWAR (RAJASTHAN)" (TOTAL ROUTE LENGTH 134.810 KM) IN RAJASTHAN PORTION ROUTE LENGTH 126.290 KM."
