A proposal has been received in this office from Executive Engineer, Saraswati Heritage Division No. 1, and Jagadhri for diversion of 31.72 ha of forest land for construction of Adi Badri Dam on River Somb within the jurisdiction of Nahan Forest Division, Tehsil Nahan, District Sirmour H.P! The site inspection of the land involved in the proposal has been done by me on dated 24.03.2023.
