vi)	Density of vegetation	::	After diversion the length of the stream is maintained as stream in 1.74 Km (6.96Ha.) and in remaining area 5.00Ha, the dugout soil was spread and 52239 numbers of saplings of local species were planted by the SCCL during 2007-2008. The survival as on date is good however the canopy is not closed. The density is about 0.6 this area of plantation will remain as plantation permanently.
vii)	Species-wise (Scientific Names) and diameter, class -wise enumeration of trees in un broken area	::	There is no un-broken area. Due to protection given the growth has improved. Plantation was taken in the original course of the Tellavagu Nallah and all along the mounds of the diverted Nallah with local species like Pongamia Pinnata, Holoptelia intergrifolia and in some patches where the soil was saline Semaroubaglauca was planted at an espacement of 5mx5M during the year 2007 (2339 Nos) to check erosion of the slopes of the diverted course 50000nos of Agave suckers were planted all along the mounds. Survival percentage 87.34%. The SCCL has also constructed o number of check dams inside the stream at the cost of Rs.6.00 Lakhs and along the banks Agave, grasses and saplings were also planted. During 2021 also the SCCL has constructed a check dam in adjoining area with a cost of Rs.4.00 Lakhs. All these check dams put together are helping in soil and moisture conservation beside providing drinking water to the wildlife.
