

SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF

A proposal has been received by this office from Nodal officer FCA Rajasthan & Executive Engineer, Water Resource Department, Division, Sikar for Construction of Mansa Mata Anicut, Village Khoh, GP. Manaksas, Tehsil Udaipurwati, District Jhunjhunu (Proposal No. FP/RJ/IRRIG/47910/2020) for diversion(Under FCA-1980) of 1.8498 hectare of forest land for non-forestry purpose.

The subject envisages the use of forest land for Construction of Mansa Mata Anicut, Village Khoh, G.P. Manaksas, Tehsil Udaipurwati, District Jhunjhunu (Rajasthan)

The site inspection of the land involved in the proposal has been done by me on dated- 28.10.2020. On inspection of the site, it is found that total forest land required by the user agency is 1.8498 hectares, out of this 0.5330 ha. is part of protected forest land of Kankariya main 57 block which is part of Mansa Mata Conservation Reserve area and 1.3168 ha. is unclassified Forest. This project is related for construction of anicut and water will store in the submergence of anicut, water will be used for wildlife also so habitation of fauna will be minorally affected by this Project .

User Agency will have to take proper care during construction of Anicut work for conservation of schedule I (Panther, wolf, peacock, birds of pray) and other fauna. Proper habitat facility should be provided by user Agency. Safety measures/ techniques should be adopted by user agency during construction of anicut for protection, conservation of fauna. Total 296 number of Trees (127 in First Plot, 95 in second plot and 74 in third plot) are found in proposed area (List of trees enclosed).

The legal status of 0.533 ha. land is Protected Forest, presently part of Protected area of Mansa Mata conservation Reserve and 1.3168 ha. land is unclassified forest.

The requirement of forest land as proposed by the user agency in Col.2 of part-I is unavoidable and is barest minimum required for project.
