The aforesaid proposed diversion area is passing through Gudem and Gangapur RF in Karjelly Range and the total length is 2970.289 meters with a width of 5.00 meters which is amounting to the total area, required for diversion in Kaghaznagar division is 1.485 and remaining area falling outside the RF with a length of 407.862 meters and area is 0.204 Hac.



In the proposed diversion area, no unique tree is found, no protected archaeological / heritage site / defense establishment or any other important monument is found in the area. The proposed diversion area is falling in "Corridor area of Kawal Tiger Reserve" through compartment number 171, 172 and 174 of Karjelly Range to an extent of 1.485 ha. There is no tree growth existing on the proposed diversion area.

The area proposed for diversion is barest minimum and unavoidable without alternatives for the project and the proposed diversion forest area with a width of road is 5.00 meters for recommended. No violation against the Forest Conservation Act, 1980 has been carried out by the User Agency. Hence it is recommended for considering the proposal.
