I along with Forest Range Officer, Mancherial staff with Road Authorities inspected the proposed diversion area for 42.548 Ha Mancherial Division of forest land in Indaram RF, Mancherial Range of Mancherial Division for construction of four laning of NH 363 Hyderabad – Karimnagar – Chanda Road from Km 0.000 (Km 2511.900) to Km 94.602 (Km 342.000) – in favour of DGM (Tech.) & Project Director, NHAI, PIU, Nirmal on 20.07.2018. The proposed area is falling in Compartment No. 683, 695, 696, 705, 708, 709, Indaram RF and of Mancherial Section and Mancherial Section of Mancherial Range of Mancherial Division.

The said areas proposed for diversion are a not a part of National park, Wildlife sanctuary, Biosphere Reserve, Tiger Reserve, Elephant, Eco-sensitive Zone corridor, Eco Sensitive Zone etc. and there is no endangered / unique species found.

The total area required for diversion in Mancherial Division for with tow lane shoulder in favour of EE (R&B), NH Division, Mancherial.

In the proposed diversion area, no unique tree species, protected archaeological heritage sites, defense establishment or any other important monument found.

In the proposed diversion area loss of assets in Gandarivanam Section for in Mancherial Range comp No. 683 of Indaram RF the same list of assest are enclosed in proposals.'

The natural forest is dry deciduous forest and its extent is different types of vegetation 42.548 Ha. Having 0.2 to 0.3 density miscellaneous plantations having Moderate density.

The area proposed for diversion is barest minimum and unavoidable without alternatives for the project.

No works in violation of the Forest Conservation Act, 1980 has been carried out by the User Agency.
