

4. The User Agency or his contractor shall not create any fire places inside the Forest area.
5. All the material required for the work shall be prepared outside the Forest area.
6. The work in the Forest area will be allowed only in the day time from 8 AM to 6 PM
7. The User Agency shall deposite NPV for the use of land of Protected Forest as per the existing rates
8. The User Agency shall restore the land in its original form after completion of the work.
