Specific recommendation of the D.C.F. for acceptance or other wise of the proposal with reasons.</p>	<p>Banspani Iron Ore Mines of M/s OMC Ltd, granted over 380.40 ha, involves 128.45 ha of Baitarani Reserve Forest, 12.1920 ha of Revenue Forest, 2.8280 ha of non- forest area recorded as forest as on and after 25.10.1980 and 44.2830 ha DLC Forest land. A total amount of Rs. 13,08,64,610/- has been deposited in Ad-hoc CAMPA towards NPV as per prevailing rate. User Agency undertakes to pay the differential amount of NPV, if the rate is enhanced upwards in future as per the prevailing rate. The proposed area is unavoidable and the barest minimum for the purpose of mining. There is no sign of prevalence of endangered, threatened and vulnerable wild fauna in the said area except movement of wild elephant often noticed in the fringed areas.</p> <p>The said proposal, is therefore, submitted for necessary approval under Sec 2(ii) of FC Act, 1980 taking the aforesaid fact into consideration.</p>
