

Inspection Note:-

The proposed site was inspected by me on 31-05-2020. The factual details regarding the proposed site and consequent findings are stated below:-

- 1- The proposed site is situated under Vaishali Forest Division, Hajipur. The proposal is regarding establishment of Retail Outlet/Patrol Pump on the approach road of Lalganj-Phakuli Road under Forest Conservation Act 1980 for opening BPCL Retail outlet, which is notified as protected forest. The approach and exit path need diversion of approach road side land. The proposed area is a part of protected forest vide Government of Bihar Notification No. 190 E dated 16-02-1994. The total area required for the project is 0.011775 Hac.
- 2- There is One tree in proposed area of diversion. There is one Chah Plant (GBH-60CM) in Entry/Exit which would be translocated in buffer area by user agency and one Chah & one Mahogani plant situated in buffer area which is outside from proposed area and not to be felled. The road side plantation has declared as notified forest. There is no rare/endangered/unique species of flora and fauna in this area. No archeological site is present near the proposed site.
- 3- There is no damage to any archeological site or any place of religious or heritage importance.
- 4- The area of proposed diversion of forest land is minimum.
- 5- The user agency has not done any construction on the proposed site.

On the basis of the recommendations of the Deputy Conservator of Forests and the inspection made by me, the proposal may be accepted.

Seven Lakh Thirty One Thousand Three Hundred & Sixty Two only), as per enclosed estimate, will be deposited by the user agency. 3- The other standard conditions can be imposed as per norms.
