

GIRTH CLASS-WISE ENUMERATION OF TREES


Trees to be damaged by the proposed diversion of 80.87 ha of forest land within the jurisdiction of WFD, Tamenglong for construction of Imphal-Kangchup-Tamenglong Road in favour of PWD, Manipur and enumeration of 0.72% over 80.87 ha (79.676 km X 10.15 m) at 19 stratified sample plots of size (10.15 m x 30 m) were carried out in open, moderate and dense forest to represent equal distribution of trees/bamboos of the proposed affected area. Certain sections of the proposed road involve widening of the existing state road and hence, few trees are liable to be damaged.

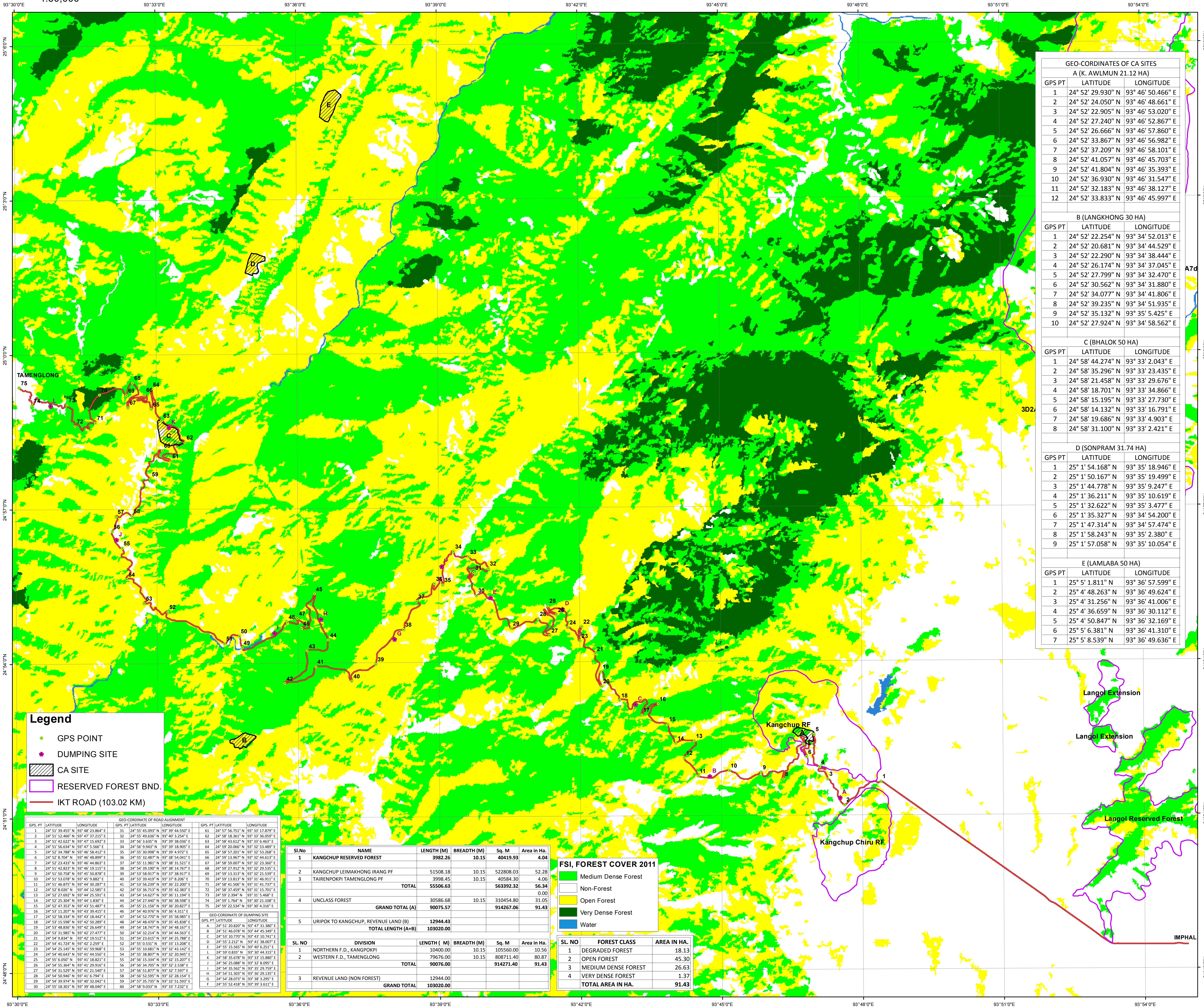





Site Inspection Report of the Divisional Forest Officer, Western Forest Division, Tamenglong in connection with the proposal for diversion of forest land measuring 80.87 ha in favour of PWD, Govt. of Manipur for construction of Imphal-Kangchup-Tamenglong Road under Western Forest Division, Tamenglong.

1. The site inspection in respect of forest land for diversion was conducted by the undersigned and RFO Tamenglong along with the representative of user agency on **1st March 2016**.
2. Vulnerability of forest land proposed is negligible in term of soil erosion as the terrain is gentle slope, existing road and tracks and compact in nature.
3. No rare/endangered/unique species of flora and fauna are found in the area except Serou, porcupine, deer, wild boar, flying squirrel etc. Birds like khalij pheasant, Jungle fowl, green doves etc are also found in the area.
4. The proposed road section does not form part of any National Park, wildlife sanctuary, biosphere reserve, tiger reserve, elephant corridor etc and the nearest point is more than **12Km** from proposed Buning Wildlife Sanctuary.
5. No protected archaeological/heritage site/defence establishment or any other important monument is located in the area.
6. The required Forest land as proposed by user agency is unavoidable and barest minimum for the project.
7. No violation of Forest Conservation Act 1980 is observed from the User Agency.




