It is submitted that in the reference 2<sup>nd</sup> cited above, the Conservator of Forests, Khammam has issued instructions to submit the proposals with detailed covering letter stating all the details furnished by the User Agency in Part-I, information given by Divisional Forest Officer in Part-II and submit to the Conservator of Forests, Khammam.

In view of the above, it is submitted that the Superintending Engineer, TDWSP Circle, Khammam has submitted the proposals in Form-A, seeking prior approval of the Government U/s.2 of the FC Act, 1980 infavour of Superintending Engineer, TDWSP Circle, Khammam for diversion of 4.562 Ha of forest land in Paloncha Division infavour of Superintending Engineer, TDWSP Circle, Khammam for laying of pipe line and Construction of Structures for Segment-25/3 under Telangana Drinking Water Supply Project through the Principal Chief Conservator of Forests, Telangana State, Hyderabad vide reference 1<sup>st</sup> cited above. The details of proposals are as follows.

- ❖ The proposed pipe line passing through Uppusaka Reserved Forest Block of Paloncha Range, which is notified under section 4 vide G.O.Ms. No. 2071 F and A For. III Dept. dt.20/11/1969 and the following Blocks of Ashwapuram Range.
  - 1) Ashwapuram RF Block, which is notified under section 4 vide G.O.Ms. No. 2071 F and A For. III Dept. dt. 20/11/1969.
  - 2) Chintiryala RF Block, which is notified under section 19 vide G.O.Ms.No. 1383 Agriculture , Dt:10-07-613.
  - 3)Gondigudem RF Block, which is notified under section 15 vide G.O.Ms.No.2202 F&A(Form-III), Dt:14-11-1968.
  - 4)Nellipaka-B RF Block which is notified under section 15 vide G.O.Ms.No.263 F&RD(Form-III), Dt:23-03-75.
  - 5)Kistasagar RF Block which is notified under section 15 vide G.O.Ms.No.92, EFS&T (Form-II-2), Dt:16.04.1993.
  - 6)Sompally RF Block which is notified under section 15 vide G.O.Ms.No.988 F&A(Form-III), Dt:05-07-72.



- ❖ The proposed pipe line comes under **Segment 25/3 (Burgampadu)** of TDWSP (Telangana Drinking Water supply project) from Segment 25/3 pipe line Net work, a part of the pipe line is proposed falls under various Reserved Forest Blocks of Ashwapuram and Paloncha Ranges and the total area required for diversion of 4.562 Ha. The pipe line alignment is proposed duly utilizing the Right of way of the existing road which falls in the various Reserved Forest Blocks of Paloncha Division and there is no other alternate alignment to proposed as the ground levels are not permitting as per the Hydrometric design.
- ❖ Map showing the required forest land, boundary of adjoining forest on 1:50,000 scale Map is enclosed.
- ❖ Cost of the project is Rs.2250.02 Crores.

#### **Justification of locating the project in Forest area:**

The User Agency has submitted that the Telangana Drinking Water Project is intended to provide safe Drinking Water to every habitation at a service level with 100 ipcd at household level from a sustainable surface water source as a part of the project, it is proposed to provide safe drinking to the people of Khammam District.

The work providing Drinking Water to habitations in Khammam District **Segment 25/3 (Burgampadu)**. All possible alternate routes for design of pipe lines have been examined and when it is inevitable and no other alternative route except through Forest and water treatment plant Structures in the Forest Area is essential to treat the raw water then supply clear water through gravity mains to habitations in the Pinapaka Constituency in Khammam District. As per the Hydraulic Designs and Topography of the area the proposed locations are very much essential for laying of pumping main, gravity mains and Construction of Water treatment plant and there are no other possible alternative alignment.

#### **Purpose wise breakup of the total land required:**

The proposed pipe line is passing through various Reserved Forest Blocks of Ashwapuram and Paloncha Ranges. The length of the road is 40.83 Kms. The break up is as follows.

- ❖ The User Agency has informed that the pipe line and structure alignment is proposed duly utilizing the "Right Of Way" of existing Road which falls in the various Reserved Forest Blocks on the head work structure is proposed duly utilizing the "Right of way" of the existing Road which falls in the various Reserved Forest Blocks.
- ❖ The User Agency has furnished an undertaking to bear the cost of raising and maintenance of CA/Penal CA, as per the Scheme prepared by State Government and also pay additional amount if any due to escalation of any changes at later date as per the demand raised by the Forest authorities.
- ❖ The User Agency has furnished undertaking to pay the NPV for acquisition of Forest land for Telangana Drinking Water Supply Project for laying of pipe line and also pay the additional amount if any due to escalation or any other charges at later date as per the demand raised by the forest authorities.



- ❖ The User Agency has furnished an undertaking to pay the cost of extraction charges of the Tree growth existing on the forest land proposed for diversion under the project as and when demanded by the forest authorities and also undertake to pay the additional amount if any due to escalation or any other charges at later date as per the demand raised by the forest authorities.

It is further submitted that as per GOI, MoEF. Lr.No.11-9-98- FC, Dt:16-06-2011 there is no Compensatory Afforestation to be insisted upon in Drinking Water Projects in Left Wing Extremism Districts where the diversion of Forest Land is up to 5.00 Ha in each project. Hence, Compensatory Afforestation is not applicable in this Project. The Part-II information along with site inspection report is submitted here with. The Part-II details are as follows.

**PART-II:**

- ❖ The proposed pipe line passing through Uppusaka Reserved Forest Block of Paloncha Range, which is notified under section 4 and (6) Forest Blocks of Ashwapuram Range which are notified under section 4,15 &19.
- ❖ The Density of vegetation in the proposed area is below 0.4 to more than 0.4.
- ❖ The existing tree growth is of Miscellaneous species like Kanuga, Vepa, Maddi, Nemalinara, Nallamaddi, Gumpena, Battaganam, Narayepa, Dirishanam, Chiruman, Billudu, Cheduvepa, Chennangi, Pachaari, Chinduga, Maredu, Ippa, Thurai and Pala etc.,
- ❖ Details of species wise and dia-meter class wise enumeration of trees is enclosed in the proposal.
- ❖ The proposed pipe line area is surrounded with Miscellaneous species as mentioned above as proposed as area is for pipe line, the vulnerability for erosion may not arise.
- ❖ No work in violation of Act has been carried out so far.
- ❖ The proposed pipe line is not falling in any National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve and Elephant Reserve Corridor etc.,
- ❖ The requirement of forest land as proposed by the User Agency is unavoidable and barest minimum for the project which is 4.562 Ha in Paloncha Division.
- ❖ In the proposed site there are no protected archaeological/heritage site/defense establishment or any other important monument is located in the area.
- ❖ There are no rare /endangered unique species of flora and fauna are found in the area.

**Specific recommendations of the DCF for acceptance:**

This project is recommended subject to the following conditions.

- i. The User Agency should not disturb flora and fauna during execution of the project or otherwise in the area.
- ii. The User Agency should follow FCA, 1980 guidelines strictly.
- iii. Recommended for acceptance of the Telangana Drinking Water Project is intended to provide Safe Drinking Water to the people of Khammam District.


