SUB: Diversion of 26.590 Ha (Revised to 28.218 Ha) forest land additional to 163.283 ha for slope protection in the project 4/6 laning of Goa-Karnataka Border- Kundapur Section of NH-66 (formerly NH-17) (km.93.700 to Km283.300) (NHAI/DBFOII/DPR/01) to be executed as Bot (Toll) Project on DBFO Pattern under NHDP IV.

With reference to the above, it is submited that the propsal for diviersion of 26.590 Ha (Revised to 28.218 Ha) forest land additional to 163.283 ha for slope protection in the project 4/6 laning of Goa-Karnataka Border-Kundapur Section of NH-66 (formerly NH-17) (km.93.700 to Km283.300) (NHAI/DBFOII/DPR/01) to be executed as Bot (Toll) Project on DBFO Pattern under NHDP IV. In which 10.505 ha of forest land falls in Honavar division. Expasion of National Highway-66 by National Highway, Authority of India (NHAI). As per additional proposal received from the Project Director, National Highways Authority of India, Project Implementation Unit, Mangalore, has submitted proposal for diversion of additional 28.218 Ha forest land in Karwar (12.518 ha), Honavar (10.505ha) and Kundapur Division (5.195ha) for 4/6 laning of Goa Karnataka Border-Kundapur Section of NH-66. Out of which 10.505 ha is pertaining to Honavar division from chainge 149+300 to 238+800, as per the details provided by the User agency.

The additional area proposed for the division, falls in chainge 149+300 to 238+800 in Balale (0.36 ha), Bargi Kurigadde (1.8 ha) village of Hiregutti range, Yattinbali (0.48 ha), Mirjan (1.23 ha), Divagi (2.51 ha) village of Katgal range, Manaki (0.4ha) village of Kumta range, Honnavar (0.6 ha), Kelaginoor (2.404 ha), Gunavante

(0.45 ha) village of Honavr range and Manki (0.117 ha), Suebeelu (0.154 ha) village in Manki range.

The User Agency has submitted an earlier proposal to extent of 63.85 ha pertaing to the Honavar Division. In additional to that an area of 10.505 ha is proposed fo diversion. (Proposal No: FP/KA/ROAD/3401/2018.) The reasons for going in for aquiring of the additional land is because of the fact that land slide at few locations due to heavy rain and in locations where road passes through hilly terrain. The user agency has proposed for an additional area in those fragile areas for carrying out slope protection works.

The User Agency has yet to furnish certificate related to ensuring compliance of Schedule Tribe and other Traditional Forest Dwellers (Reorganization of Forest Rights) Act 2006 as per MOEF s latter No:11-9/98-FC (Pt), dated: 05-07-2015. (ROFR Certificate) from Deputy Commissioner in FORM-I(Linear projects) to be submitted to jurisdictional CCF.

The proposed diversion of forest land pertaining to the Honavar Division in (7) set is enclosed herwith duly filling Part-II for further needful action in the matter.
