SITE INSPECTION REPORT- NOT BELOW THE RANK OF DCF

5.1 A proposal has been received by this office from **Executive Engineer Provincial** Division P.W.D.Almora for diversion under FCA-1980) of 3.442 ha. of forest land for non-forestry purpose. The project envisages the use of forest land for construction of **Shaarfatak to Dau Ghoriya- Motor Road** The site inspection of the land involved in the proposal has been done by me on dated 16 - 9 -2020

5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring 3.442 ha.

5.3 The requirement of forest land as proposed by the user agency in Co1.2 part-1 is unavoidable and is barest minimum required for the project. **Yes**

उक्त प्रस्तावित मार्ग 5 किमी० लम्बाई तथा 9 मीटर चौड़ाई में गठित किया गया जिसमें आरक्षित वन भूमि 2550 मीटर यानि 2.295 है० वन पंचायत भूमि 1275 मीटर यानि 1.147 है० तथा 1175 मीटर यानि 1.058 है० नाप भूमि प्रभावित होती हैं । उक्त प्रस्तावित मार्ग 691 वृक्ष विभिन्न प्रजाति के प्रभावित होते हैं । जिसमें बोंज प्रजाति के 74 वृक्ष प्रभावित होते हैं । स्थल निरीक्षण के दौरान स्थानीय जनप्रतिनिधियों द्वारा अवगत कराया गया कि उक्त मार्ग के निर्माण से ग्राम झोल तथा दो ग्रामीणों के 431 परिवार जिसकी जन संख्या 2232 हैं लाभान्वित होते हैं । अतः प्रस्ताव को भारत सरकार की स्वीकृति हेतु अग्रसारित किया जाता है ।
