Specific recommendations of the DCF for acceptance or otherwise of the proposal with reasons.

As the proposed project is taking the bare'st minimum area of Reserve Forest and there is no other alternative available. This pject can be recommended which will benefit villages in transportation agricultural produce to the nearest market centres.

Thus, the diversion area of **2.942** Ha for formation of BT Road from ZP Road 27/9 Km to Gundala via Doddiguda of Tiryani Mandal with **reduced width of 6.00 meters** over a length of 4904.73 meters, which is falling in Rally (P) Reserve Forest in Asifabad Forest Division, is **recommended** considering all the aspects mentioned in the proposal and field conditions.
