SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF

(For the Forest land to be diverted under FCA)


1. A proposal has been received by this office from Area Sales Manger (Faridabad Sales Area) Gurugram Retail Regional office HPCL. for diversion (under FCA-1980) of 3.90 ha of forest land for construction of 6 lane access controlled highway form DND Faridabad Ballabgarh bypass junction with Delhi Vadodara express way KMP interchange (NH-148 NA) under Bharatmala priyojna (Lot-4/PKG-1) under Forest Division and District Faridabad under Forest Division and District Faridabad. The site inspection of the land involved in the proposal has been done by me on date 26.04.2021
2. On inspection of the site, it is found that the land required by the user agency is a **protected forest measuring 3.90 hec.**
3. The requirement of forest land as proposed by the User agency in Col. 2 of part-I is unavoidable and is barest minimum required for the project. **Barest minimum.**
4. Whether any rare/endangered/unique species of flora and fauna are found in the area. If so the details thereof. **NO**
5. Whether any protected archaeological/heritage site/deface establishment or any other important monument is located in the area. If so, the details thereof with NOC form the competent authority. **NO**
6. (a) The user agency has violated the provisions of Forest (Conservation) Act, 1980 and no work has been started without proper sanction.
- (b) **It has been found that the user agency has not violated the Forest (Conservation) Act, 1980 Indian Forest Act, 1927/any other forest Act.**

As it is clear that forest area under consideration is Protected Forest of Uttar Pradesh Govt. and under ownership of Uttar Pradesh Govt. As directed by their office letter no.25-445/20219ROC dated 15.02.2021 Regional Empower Committee that this case has to be processed by the forest department of Haryana State under whose jurisdiction this area falls after getting a clear and un-ambiguous N.O.C from Uttar Pradesh Govt. It has been directed by MOEF office New Delhi that this case of diversion should be processed irrespective N.O.C has been received or not from Uttar Pradesh Govt. . Therefore this case has been proceed from this office without getting clear and un-ambiguous N.O.C from Uttar Pradesh Govt. This case may be decided only after getting the requisite N.O.C at the higher level.

The proposal is recommended for acceptance.
