With reference to the above, it is submitted that the Principal Chief Conservator of Forests, TS, Hyderabad has issued instructions to prepare the CA Scheme in double degraded Forest including maintenance from 7-10 years information in Part-II with specific recommendation to the Conservator of Forests, Khammam for Diversion of forest land under F© Act, 1980 to an extent of 37.7154 Ha for erection n of 400 KV QMDC line from the proposed 4x270MW Bhadradhri TPP near Manugoor to the proposed 400/220 KV SS at Padamati Narsapuram (V), Julurupadu(M) in Khammam District in which (1) 19.2096 Ha of forest land of Chantakonda RF Block of Kothagudem Forest Division, (2) 4.9358 Ha of forest land in Chintriyala RF & Ratangutta (Pamulapalli) RF of Paloncha Forest Division and (3) 13.57 Ha of Forest Land in Chatakonda &Punukula RF in Paloncha Wild Life Forest Division.

It is further submitted that in view of the above the Forest Range Officer, Ashwapuram was instructed to identify the double the degraded forest area towards CA. Accordingly the Forest Range Officer, Ashwapuram has identified the double the degraded forest area to an extent of 10.00 Ha in Compt.No.4, Manuguru(S) Beat, Manuguru Section of Ratnagutta RF of Ashwapuram Range. The CA Scheme has been prepared as per FSR 2015-16 and technically sanctioned by the Conservator of Forests, Khammam to an amount of Rs.13.103 lakhs. The details are as follows.
