FIELD INSPECTION NOTES OF THE DISTRICT FOREST OFFICER, SIDDIPET IN RESERVE FOREST LAND ON 23- 12-2021.

Today, I along with the Forest Range Officer, Gajwel and their field staff have inspected the Reserve Forest areas proposed for diversion of (0.9042) Ha of Forest Land in Dasarlapally RF for laying of road access to M/s.G.M.R Rock Sand Crusher Plant at Sy.No.89/B, Baswapur (V), Mulugu (M), Dist.Siddipet in favor of M/s. GMR Rock Sand, Siddipet as detailed below:

The said area is passing through the Dasarlapally RF, The canopy of this area is 0.1 and No trees are required to be removed from the said area. The dominant species in this area are 1) Vepa (Azadirachta indica), 2) Nalla Jeedi (Semecarpus anacardium), 3) Soppera (Dalbergia paniculata), 4) Teak (Tectona grandis), 5) Moduga (Butea monosperma), 6)Neelagiri (Eucalyptus globules), 7) Bamboo (Bambusa vulgaris) etc., Enumeration and valuation of the tree growth is Nil in the proposed area.

I have searched for other alternatives, but there is no alternative land available except the present proposal and it is found that as requested by the User Agency there is no necessity of 0.9042 Ha. of Forest Land as the User Agency has requested for diversion of 19 Meters width and 475.93 Meters Length but on my verification it is found that 12-16 Meters and at the ending 7-8 Meters width and 475.93 Meters length is more than sufficient for the User Agency by which the total area comes to (0.40) Ha. and this is the barest minimum area that is required for formation of approach road to the M/s.G.M.R Rock Sand Crusher Plant at Sy.No.89/B, Baswapur (V), Mulugu (M), Dist.Siddipet. Further the Chain link erected by the Department is getting disturbed due to the proposal. Hence erection of Chainlink proposal need to be included in the CA Scheme proposal. No work is started as on date in violation of FC Act 1980. There are no encroachments and also claims in the RF area that attracts the RoFR Act 2006.

- 1. The area does not fall in wildlife protected areas, archaeological heritage site, important monument there are no claims pending under RoFR Act.2006.
- 2. There are no endangered species that are caused or harmed due to for formation of approach road to the M/s.G.M.R Rock Sand Crusher Plant at Sy.No.89/B, Baswapur (V), Mulugu (M), Dist.Siddipet.
- 3. Further CA scheme proposed for 1 Ha. DFL.
