### 8.3 Compensatory Afforestaton:-

Compensatory afforstation shall be taken up by the Forest Department over 87.00 ha non forest land (i) Area 77.00 ha. in Gut No.117 at Village Sutare, Tahsil Sakari, Dist. Dhule (ii) Area 10.00 ha. in Gut No.83/2 at Village Satarpada, Taluka Sakari, Dist. Dhule at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.

- 8.4 The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
- 8.5 The boundary of the diverted forest land shall be demarcated on ground at the project cost by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number toward and back bearing and distance from pillar to pillar.
- 8.6 The Project Authority should provide water to forestry and allied purposes at the rate fixed by the Government of Maharashtra.
- 8.7 The forest land shall not be used for any purpose other than specified in the project.

- 8.8 The project authority will defray the cost of Net Present Value of 73.94 ha. of forest land
- as per the latest Guideline of the Government of India.

  8.10 The forest land shall not be utilized for any purpose other than specified in the project
- 8.11 No damage shall be caused to the flora and fauna of the area.
- 8.12 No labour camp shall be established on the forest land;
- 8.13 The user agency, if required, shall undertake comprehensive soil conservation measure at
- the project cost in consultation with the Forest Department. 8.14 A Catchment Area Treatment Plan shall be prepared, and implemented under the
- supervision of the Forest Department at the project cost, if applicable; 8.15 The user agency shall obtain environmental clearance, 2006, if required.
- 8.16 The user agency shall carry out muck disposal at pre- designated sites in such manner so as
- S.17 The dumping area for muck disposal shall be stabilized and reclaimed by planting suitable species by the user agency at the cost of project under the supervision of State Forest Department. Retaining walls and terracing shall be carried out to hold the dumping material in place. Stabilization and reclamation of such dumping sites shall be completed before handing over the same to the State Forest Department in a time bound manner as
- per plan;
  8.18 The user agency shall consult organizations (s) having experience in construction of roads in hilly areas to avoid frequent road blocks due to landslides etc. and shall provide breast
- walls and retaining walls wherever necessary; 8.19 The layout plan of the proposal shall not be changed without the prior approval of the
