

FIELD INSPECTION NOTE OF THE FOREST DIVISIONAL OFFICER, KAGHAZNAGAR IN KAGHAZNAGAR DIVISION

Today on 30.08.2020 inspected the proposed diversion area of **7.451 Hac** for for improvement of existing road from RF Karjevelly to Motlaguda (Etiguda to Agarguda via Gundepally) RF Bejjur. of Kaghaznagar Forest Division in favour of District Panchyat Raj, Engineer Komarambheem-Asifabad District along with concerned staff. As per the field verification, the details which are as follows.

The aforesaid proposed diversion area is passing through Bejjur RF in Bejjur and Penchikalpet Ranges and the total length **14777.80 meters (7.391 Ha)**, with a width of **5.00 meters (2) Culvert width of 10 metres over a length of 30 mts (0.06 Ha)** which is amounting to the total area, required for diversion in Kaghaznagar division is **7.451 Hac**.



It is further submitted that, as per the field condition and wild life movement of the proposed diversion area the animal underpasses is proposed for (18 Nos) to be constructed by the User Agency at the project Cost details area is detailed below.

In the proposed diversion area, no unique tree is found, no protected archaeological / heritage site / defense establishment or any other important monument is found in the area. **The proposed diversion area is falling in "Corridor area of Kawal Tiger Reserve" through compartment number 243, 245, 255, 256,, 252, 258, 249 and 250 of Bejjur and Penchikalpet Ranges to an extent of 7.451 Ha.** There is no tree growth existing on the proposed diversion area.

The area proposed for diversion is barest minimum and unavoidable without alternatives for the project and the proposed diversion forest area with a width of road is 5.00 meters is recommended. No violation against the Forest Conservation Act, 1980 has been carried out by the User Agency. Hence it is recommended for considering the proposal.
