**FIELD INSPECTION NOTES OF FOREST DIVISIONAL OFFICER, KAGHAZNAGAR IN COMPT.NO.218, 219 OF SOMINI BEAT OF BEJJUR RANGE OF KAGHAZNAGAR DIVISION**

During the field inspection on **06.10.2020** with User Agency authorities and concerned staff. It is observed that (2) Bridges required for construction on the proposed road from Bejjur to Somini in Compt No. 218 & 219 and the User Agency Authorities have also stated that they require **(2) Bridges on the proposed road and the Bridge length is 200 mts each with a width of 12.00 Mts and area required for Bridges is 0.480 Hac.** But the user agency has not included the culvert in this project.

As per the field verification requirement of improvement of existing road from Bejjur to Somini, it is recommended the width of road for 5.00 Mtr over the length is 3713.86 mts and area for diversion 1.857 Ha and the Bridges length is 200 mts each with a width of 12.00 Mts and area required for Bridges is 0.480 Hac.

As per justification given by user agency and the field conditions, the barest minimum and unavoidable area for the project is **2.337 Ha.** including the Bridges.

The User agency has proposed the length of road is **4.1139 meters** and width is **10.00 meters** and the diversion area as **4.1139 Ha** in Kaghaznagar Division. The proposed diversion forest area for improvement of existing road from Bejjur to Somini in Bejjur Mandal is passing through interior forest area and the surrounding areas covered with good flora and fauna and the road dead end with the village Somini.

As per the field verification, the proposed area is passing through the following Reserve Forest; the details are as follows.

The aforesaid proposed diversion area is passing through Gudem RF in <sup>Bejjur</sup> ~~Somini~~ Range. The total length is **4113.86 meters** with a width of **5 meters** and **12 Meters for construction of bridges (2 Nos)** which is amounting to the total area, required for diversion in Kaghaznagar division is **2.337 Ha.**



In the proposed diversion area, no unique tree is found, no protected archaeological / heritage site / defense establishment or any other important monument is found in the area. **The proposed diversion area is not falling in "Corridor area of Kawal Tiger Reserve" through compartment number 218 & 219 of Bejjur Range to an extent of 2.337 ha.** There is no tree growth existing on the proposed diversion area.

The area proposed for diversion is barest minimum and unavoidable without alternatives for the project. No violation against the Forest Conservation Act, 1980 has been carried out by the User Agency. Hence it is recommended for considering the proposal.
